2. Nomination papers must be delivered to the Returning Officer, Three Rivers House, Northway, Rickmansworth, Herts, WD3 1RL on any day after the date of this notice but no later than 4 pm on Tuesday 13th December 2016.
3. If any election is contested the poll will take place on Thursday, 12th January 2017.
4. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Three Rivers House, Northway, Rickmansworth, Herts, WD3 1RL by 5 pm on Friday 23rd December 2016.
5. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Three Rivers House, Northway, Rickmansworth, Herts, WD3 1RL by 5 pm on Wednesday, 4th January 2017.
6. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Three Rivers House, Northway, Rickmansworth, Herts, WD3 1RL by 5 pm on Thursday, 12th January 2017. The physical incapacity must have occurred after 5 pm on Wednesday, 4th January 2017. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday, 4th January 2017.
